Water-based primer VEZAKRILPRIMER, VEZ.

· **Product category** VEZAKRILPRIMER is a coarse primer applied before water-based dispersion products.

· Application of the substance / the mixture

VEZAKRILPRIMER is a water dispersion of polymeric binders filled with fine quartz sand. It is suitable for coating very smooth concrete surfaces, fibre-cement boards and gypsum-cardboards before various linings are fixed onto them or before decorative renders are applied. It can also be used as an adhesive bond when fixing ceramic tiles onto old ceramic linings.

The coat substantially increases roughness of the surface and ensures adhesives or renders applied later to adhere onto it better, it equalises the surface with regard to water absorption, slightly increases its water repellency and binds dust and other badly-adhered particles which could not have been removed with cleaning for whatever reason.
